### Dear PCHC Friends,

In the pages of this report we hope you will find Pueblo Community Health Center's (PCHC) mission and core values alive and well. PCHC is the trusted health care home for one in seven Puebloans. When the Center does well, the community does well.

Among the many accomplishments achieved in 2014, there are several that deserve special mention. First, the quality of care we provided remains very high; inside this report you will see evidence of this. Second, a 7,000 square foot addition to our Colorado Avenue Clinic was completed. This expansion provides space to serve more patients and increase the reach of our integrated services. Third, PCHC assisted 5,930 uninsured patients with enrollment into Medicaid or the Connect for Health Colorado health insurance exchange. The result is fewer uninsured people and increased access to preventive and primary care services. Finally, and most importantly, PCHC employs people who are deeply committed to providing care that is worthy of our patients' trust.

We finished 2014 fiscally sound and are operating on a sustainable basis. Key to our long term viability is successful physician recruitment and local partnerships. We, like others throughout the community, have been challenged with the recruitment of doctors. The demand for family practitioners is very high and the supply is low. We continue to take steps to attract new doctors to PCHC and work hard to retain the medical staff we have. Community partnerships are many, but we are especially grateful to Parkview and St. Mary Corwin Medical Centers, local specialty physicians, Southern Colorado Family Medicine Residency, Spanish Peaks Mental Health Center, Pueblo City-County Health Department, United Way of Pueblo County, Posada, Pueblo City Schools and Pueblo County School District 70 for working with us to serve patients and the community's health care needs.



## **Race and Ethnicity:**

- 63% of patients at PCHC are of racial and/or ethnic minority
  The largest percentage of that is comprised of people of Hispanic/Latino ethnicity--60.3%
- 96% of PCHC patients live at or below 200% of Federal Poverty Level (FPL) (FPL at 200% for a family of 4 is annual income of \$47,700 in 2014)
- 64.6% of PCHC patients live at or below 100% of Federal Poverty Level (FPL at 100% for a family of 4 is annual income of \$23,850 in 2014)

## **Medical Conditions:**

- 17.4% of patients have Hypertension (high blood pressure)
  65.2% of those patients have their blood pressure under control (<140/90)</li>
- 10.7% of patients have Diabetes
  66.6% of those patients have their diabetes under control (HbA1c <=9%)</li>


### **Health Outcomes:**

# **Meaningful Use**

As the use of Electronic Health Records (EHR) technology becomes omnipresent in health care, PCHC has adopted EHR in a way that is smart and keeps quality and patient trust at the forefront. PCHC implemented its EHR May, 2013. After 18 months of utilization, we are able to compare our use of EHR against nationally recognized standards called "Meaningful Use". These standards are set by the U.S. Department of Health and Human Services and applicable to all health care providers. These measures are intended to reflect efficient use of EHR technology in a patient care setting. As noted in the table below, PCHC is excelling in its use of EHR compared to national standards.
